Thanks so much for sending in the information and the recommendations. As you well know, there's a lot of information here with many recommendations and projects involving multiple technologies that span multiple countries.

Katrina will be point for working with you to put you in touch with the relevant people who manage our efforts in the different countries and who also are leads for the particular technologies.

First, I recommend that you consider having your company become a formal Power Africa partner, which requires some level of vetting (but that's not too onerous). Sarah Dimson can provide you information on that process.

With respect to the projects themselves, it would be helpful prior to engaging with Katrina to

try to rank/prioritize the proposed projects in terms of where you think your team might best focus its efforts for success. Based on what you've sent us, we could end up engaging with teams in Uganda, Rwanda, Nigeria, Sierra Leone, Ghana, etc. and spreading your own resources/bandwidth too thin. If you're looking for some quick wins, let's try to zero in on one or two specific projects so that we can try to test your model, etc.

I will look to Katrina to update me on your discussions with our team, but please don't hesitate to reach out. I'm traveling quite a bit over the next few weeks.
